The purpose of these monthly articles is to inform you of Board of Directors (BOD) activities and to make available other information that is important to you.

Thank you Bob! Bob, you can now resume a more stress-free retirement lifestyle!! Yet, change is healthy in any organization. Kent Ward has volunteered to assume the responsibilities of President. With ten years of active Board service, Kent brings much experience and institutional knowledge to the job. Bob Shafer, helping with the transition, will serve as Vice-President.

The Expanding Role of the Property Manager

A Failed Hot Water Tank Will Cost You Dearly Yet another failed unit hot water tank has resulted in a very costly affair (\$10K+). This time the water penetrated six (6) units! Unit Owners who do not replace their older hot water tanks BEFORE THEY FAIL are exposing themselves, and the Association, to large financial losses. Florida state law has greatly increased the financial exposure of the Association. In addition to the financial aspects, water damage causes much unnecessary heartache for all. The BOD asks that you replace your older model hot water tank BEFORE it fails. Note from Kent: While replacing your old hot water tank, please replace that old main water shutoff (gate) valve with a new ball valve. As we humans tend to leak with age, so does the old valve!!!!Thank you in advance.

And Yet Another Change Ken Swierenga has taken over as Chairman of the Buildings and Grounds Committee. Since inception six years ago, the B&G has been very active and productive, mostly under the leadership of Henry Kostuck. This important volunteer committee has in fact saved the Association over \$50,000 in maintenance costs. They have and continue to do an outstanding job! Thank you gentlemen and thank you Ken.
